# 1. Opening Prayer

#### 2. Devotion

Anthony Grafals presented tonight's devotion, "Jesus Sends Out the Twelve".

# Devotion Highlights:

- Matthew 10
- In Matthew 10 the Bible speaks of Jesus sending his 12 disciples out into the world. Verses 6 & 7 say, "Go rather to the lost sheep of Israel. As you go, proclaim this message: 'The kingdom of heaven has come near'." The Board can be seen as a similar group of 12, when including the Head of School.
- Anthony read the NIV version of Matthew 10 and then compared it to the The Message version. The
  Message version is a paraphrased version, which, in turn, empowered Anthony to provide his own
  paraphrased version:
  - Those that Jesus sends out, he empowers and calls on to care for the least among us, like the children.
  - Help those who we can, right here in our midst.
  - Travel light.
  - Live modestly.
  - Approach others with a willingness to share God's Word.
  - Don't call attention to our work.
  - Just speak the words God provides.
  - Don't give up; He is coming.
  - Any treatment we receive is better than the treatment given to our Lord. So be content.
  - Don't be intimidated.
  - God loves us.
  - Jesus will claim us as His children.
  - Life is hard and people will always disappoint.

- If we love Him first, He will love us even more.
- We are all engaged in this harvest work together. Those who accept what we do are with us. We must help them and seek help from them. This is a great commission from God that we advance with even the smallest acts.
