Darius Perkins presented:

Our Greatest Fear

The fear of being alone or separate can be petrifying to many people. A new child in the neighborhood sobbs to her mother, "no one ever plays with me." The fear of being alone drives many of us to noise or engage in activity. Generations past would call it being a busy body. But research suggests that this need for constant noise or activity can lead to what is called chaos addiction. It is a condition in which a person becomes addicted to the rush that they feel when chaos is all around them. The problem is that humans were not typically designed for a constant stream of words or activity. Information is taken in through the senses; the sense of touch, the sense of sight, the sense of hearing, sense of taste, and the sense of smell. This information is then transferred through our nerves into our spinal cord and then into our brain. Our thoughts automatically generate a response either positive, negative, or neutral. If we tend to exaggerate the importance of something our emotions will identify this information as stress which our bodies respond by releasing a hormone also known as adrenaline into the blood which keeps us in a constant fight or flight state. "COBRA" One of the costs of constantly receiving a stream of noise or activity is a greater temptation to avoid quietness."

My soul, wait in silence for God only, for my hope is from Him. He only is my rock and my salvation, my stronghold; I shall not be shaken." (Ps. 62:5–6)Silence clears the storms of life and frees our minds for wise decision making and planning.

Luke 6:12–13 tells us that Jesus spent time in silence and solitude when deciding whom to choose as the disciples who would travel with him: "And it was at this time that he went off to the mountain to pray, and he spent the whole night in prayer to God. And when day came, he called his disciples to him; and chose twelve of them, whom he also named as apostles. We must cultivate an inner solitude and silence the noise and activity so that our minds, bodies, and souls can experience peace, health, and prosperity in a world that is filled with turmoil. B. Payroll Protection Program Vote

On Wednesday, April 15th, 2020, there was an email vote in regards to the Payroll Protection Program (PPP) application and approval took place as follows:

VCS submitted an application for the Payroll Protection Program per the CARES Act of 2020, enacted to stabilize operations during this COVID-19 economic disruption. Ben, the school's representative, Scott as Chair, and Becky as Treasurer, completed the application quickly to ensure timely processing. Our Lender has approved the request and has forwarded the documents for electronic signature.

VCS is eligible for relief on the program's guidelines to be repaid with 1% interest beginning six months after the application date and completing eighteen months thereafter. These are great terms to leverage funds when our income is questionable. However, this loan is forgivable to the extent that it is used for maintaining payroll, mortgage interest, and utilities for an eight week period after the funds are received. The grant process is not documented in the Note's terms but the CARES Act and PPP are. The school will have about ninety days to submit its spending documentation for review and approval prior to the first payment date.

Rosemary is confident that the school will realize a nearly 100% grant! This is a true blessing that can help the school in so many ways. Praises!
