

Payment Information

Tuition Payments:

Tuition must be paid in full by July 1, 2021 by cashiers check, personal check or wire transfer.

Monthly payments must be set up with Smart Tuition, an outside billing service, allowing parents flexibility in making payments for sports, clubs, lunches and miscellaneous items the student may incur.

Miscellaneous Fees Payment:

There are three payment options available to pay miscellaneous fees in excess of \$1,000 deposit via Smart Tuition:

- Electronic funds transfer from your bank account
- Credit Card (Master Card, American Express, Discover or Visa)
- Payment by check

Missed Payments: A \$40 follow-up fee will be assessed by Smart Tuition for each missed payment. A late fee of \$35 will be charged by VCS for any late payment. Accounts remaining past due are reported to a credit reporting agency. Students may be subject to immediate dismissal from Vacaville Christian Schools if their tuition account becomes 30 days past due.

Withdrawal Policy:

Your contract is for the entire school year.

To withdraw a child from VCS after the student has been accepted, a withdrawal form must be completed by the parent, agency and submitted to the Admissions Office. If withdrawing after acceptance, including prior to the 1st day of school and during the 1st semester (prior to October 15, 2021), tuition will be refunded for 2nd semester only. If withdrawing after October 15, 2021, the entire school year **tuition amount is non-refundable**. You are responsible for the balance of tuition regardless of the reason for the withdrawal. This includes withdrawal at the request of the school.

Application Fees

New Student 7th - 10th: **\$275.00** Application Fee due with completed application. Applications must be submitted by the agency representing the student. All students must have an agency or local family member sponsoring them to be eligible for admissions.

\$275.00 Enrollment Fee due within 7 days of acceptance, along with signed contracts and Smart Tuition account registration confirmation.

\$5,000 Non-Refundable Tuition Deposit due with contracts no later than June 1, 2021.

Remaining tuition payment is due IN FULL, no later than July 1, 2021. Failure to submit tuition in full by July 1, 2021 will result in a cancellation of the student’s I-20 and acceptance to VCS for the 2021-2022 school year.

Tuition includes: Summer Immersion Program and materials, daily ESL/accluturation program and materials, TOEFL Jr. testing, AP classes if desired (does not include AP testing fees), personal locker, college counseling, school provided tutoring, and mentoring.

Payment: 1 annual payment in full is due by July 1, 2021 and must be paid by cashiers, personal check or wire transfer. All other miscellaneous fees (see below) in excess of \$1,000 deposit will be billed to your Smart Tuition for payment.

Miscellaneous Fees Not Included in Tuition

Yearbooks, field trips, cap and gown, graduation fees, class projects, spirit clothes, clubs, athletics, band, social events, physical education uniforms for 7th-9th grade only, AP testing fees, lunch, snack bar, etc. **\$1,000 of your tuition covers such things. These fees are billed as they occur. This will be deposited into the students surplus account to start the year. If the student uses all of the \$1,000, a deposit must be made to the account to cover additional expenses.**

*Other expenses not included in tuition: Student’s personal travel expenses, embassy/visa fees, home stay fees, and iPad.

Extended Care Rates

ANNUAL | Grade 7th & 8th: \$3736

Drop In: 7th - 8th Grade

\$7.00 per hour (15 minute increments)



- **MINIMUM DAYS:** Extended Care will be available on minimum days at the rate of \$7.00 per hour. Minimum days are included **ONLY** for students enrolled in the Full-Time program from 6:30 a.m. – 6:00 p.m.

- Late pick up fees will be applied after 6:00 p.m. at a rate of \$15 per each 15-minute increment or portion thereof, per occurrence, per child. After two (2) occurrences, the late pickup charge of \$15 per 15-minute increment will double to \$30 per increment, per occurrence, per child.
