Military Discount



In consideration for accepted enrollment to Vacaville Christian School's (VCS), the _____
Family will have VCS administer all tuition discounts and terms defined within this Military Discount agreement.

- 1) **Military Discount:** Family to receive **up to ten (10)** monthly credits of \$100 each for tuition discount on highest remaining monthly school tuition paid for each child the first year enrolled. If the New Family has accumulated multiple discounts, then all applicable discounts will be applied to the highest remaining tuition balance first then work down to the lowest remaining tuition balance.
- 2) **Term:** All discounts will be in effect for the current school year.
- 3) **Allocation:** This discounts will be allocated to current tuition that is outstanding at the time of validation. The total discount amount will not exceed the total amount of tuition for the current school year and does not extend into the following school year.
- 4) **Distribution:** These discounts will be distributed on a monthly basis except if the tuition has been prepaid in full. In this case, the discount will be applied in a lump sum to the tuition account. This credit can then be used to pay any other fees on the account. If a credit is remaining at the end of the school year, the discount will roll over to the next school year.
- 5) **Retroactive:** All discounts will NOT be retroactive to past tuition that has already been paid except if the tuition has been prepaid for the entire school year.
- 6) **Assignment:** The New Family has the right to assign their discounts to any VCS family with the approval of all parties. Assigning party will release any claim to said discount should they elect to carry out this transfer. All terms will remain the same.
- 7) **Payment Delinquency:** Should the New Family become 30 days behind in tuition payments, all discounts to the delinquent party would become suspended until said account has become current.
- 8) **Notification:** Your monthly billing will serve as notice of any changes to these discounts.
- 9) **Validation:** This agreement shall be considered validated when VCS has reviewed and confirmed that all parties have met all definitions and criteria defined in the Military Discount Addendum and a VCS authorized representative has signed this agreement.

Glossary and Clarification of Terms

The purpose of this Addendum is to clarify and define terms of the Military Discount and to define the Criteria needed to participate in this program.

- 1) **New Family:** A New Active Duty Military Family is qualified to receive a discount under this program when no child of a parent in that family has applied for enrollment and has attended any VCS class within the previous 36 months. The student must be enrolled in PS (5 Day All Day Program) through 12th grade.
- 2) **Term:** The time or period through which something lasts.
- 3) **Allocation:** The process of determining how much of a discount will be distributed to a New Family.
- 4) **Pro Rations:** To divide, distribute, or calculate proportionately.
- 5) **Distribution:** The process in which the discount will be given to a New Family.
- 6) **Retroactive:** Extending in scope or effect to a prior time or to conditions that existed or originated in the past.
- 7) **Assignment:** The transference of a right, interest, or title, or the instrument of transfer to another party.
- 8) **Payment Delinquency:** A definition of when a tuition payment is past due.
- 9) **Notification:** The formal process of making known any changes to the agreement.
- 10) **Validation:** The process in which VCS will make sure that all parties have complied with and are eligible to participate in Military Discount Program.

Criteria

- 1) All VCS families who wish to participate in this agreement must be in good standing and are enrolled in PS (5 Day All Day Program) through 12th Grade.
- 2) Preschool & Kindergarten Readiness must be enrolled in the 5 day All Day program.
- 3) To be in good standing, the VCS family must not have any outstanding fees with VCS and must be clear from any academic and administrative review processes.
- 4) The Military Discount is per child for the school year.
