Payment Information

Payments: Monthly tuition payments must be set up with Blackbaud Tuition Management, an outside billing service allowing parents flexibility in making payments.

There are three payment options available:

- Electronic Funds Transfer from your bank account
- Credit Card (Master Card, American Express, Discover or Visa)
- Payment by check

Missed Payments: A \$40 follow-up fee will be assessed by Blackbaud Tuition Management, for each missed payment. A late fee of \$35 will be charged by VCS for any late payment. Accounts remaining past due are reported to a credit reporting agency. Students may be subject to immediate dismissal from Vacaville Christian Schools if their tuition account becomes 30 days past due.

Withdrawal Policy:

Your contract is for the entire school year, August to May. To withdraw a child from VCS Early Education Department, thirty-day (30) written notice is required and a withdrawal form must be completed by the parent and submitted to the Business Office. This applies to the thirty (30) days prior to the first day of school or attendance. The August 1st payment is due unless notice is received before July 1st. You are responsible for tuition payments for the thirty (30) days following notification of withdrawal, even if your child does not attend school.

Extended Care Billing Information

- Late pick up fees will be applied after 6:00 p.m. at a rate of \$50 per each 15-minute increment or portion thereof, per occurrence, per child. After two (2) occurrences, the late pickup charge of \$50 per 15-minute increment will double to \$100 per increment, per occurrence, per child.
- Occasional Days: Use of hours before or after program times requires approval from VCS Early Education Supervisor and will be billed at the drop-in rate of \$24.00 per hour in 15-minute increments. Older Preschool students who are approved to attend on a day outside of their program will be charged \$75 for morning only (8am-12pm) and \$140 for a full day.
- Miscellaneous Fees: Hot lunches(optional), mat covers, field trips and t-shirts.
